

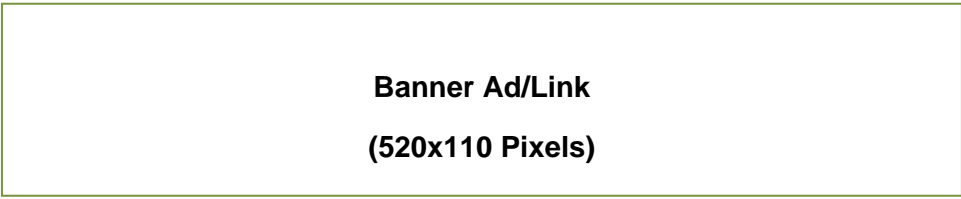
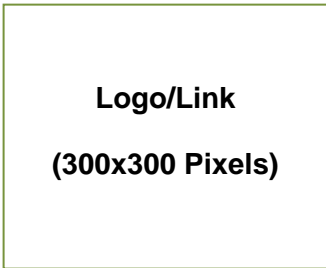

Several interesting stories have broken over the past month, including the recent announcement by President Trump about the imminent [new Waters of the U.S. \(WOTUS\) rule](#) at the American Farm Bureau Federation's annual meeting in Austin, Texas last weekend. We also learned that the Council on Environmental Quality (CEQ) posted a Notice of Proposed Rulemaking in the Federal Register to update the [National Environmental Policy Act \(NEPA\)](#) regulations.

In National News, you'll find a story about how the Department of the Interior plans to update their [wetland assessment maps](#) and clarify the appeal process. And in State News, you'll find several stories of interest, including one on [Bismarck's new wetlands ordinance](#).
